FRANK STAGG:

"I want my memorial to be peace with justice."

Proinsias (Frank) Stagg was born in Bloomfield, Hollymount, Ballinrobe, Co. Mayo on October 5, 1941. He was the seventh of thirteen children born to Mary (née Vahey) and Henry Stagg, a farmer who was a veteran of the War of Independence and the antitreaty side in the Civil War.

Frank attended Newbrook primary school and the Christian Brothers secondary school at Ballinrobe. He was known for his skill at Gaelic Football and Handball, in which he won Mayo and Connacht Minor Championships. He also liked to sing.

He later emigrated to England where he found work as a bus conductor, then bus driver. In 1970, he married Bridie Armstrong, who came from Carnicon, Co. Mayo. He always returned home to Mayo for his holidays.

In 1972, he joined the Sinn Féin cumann in Luton, England and then soon joined the Provisional IRA. Frank was arrested in Coventry in April 1973 along with six others. He was convicted of criminal damage and conspiracy to commit arson. Frank was said be a commanding officer. He was sentenced to 10 years.

He was first sent to Albany Prison on the Isle of Wight. There he refused to do any prison work, insisting he was a political prisoner and not a criminal; for which he was placed in solitary confinement. On March 31, 1974, after being moved to Parkhurst Prison, he joined a Hunger Strike demanding to be transferred to an Irish prison with sisters Marion and Dolours Price, Hugh Feeney, Gerry Kelly and fellow Mayoman Michael Gaughan; to whom he grew very close.

On April 10, Frank And Gaughan were transferred to the prison hospital. Two weeks later began the force-feeding. The National Hunger Strike committee describes the process: "six to eight guards would restrain the prisoner and drag him or her by the hair to the top of the bed, where they would stretch the prisoner's neck over the metal rail, force a block between his or her teeth and then pass a feeding tube, which extended down the throat, through a hole in the block."

Gaughan died after a brutal force feeding on June 3, 1974. Frank was devastated by his death. Gaughan's funeral and burial in Ballina brought a huge turnout of support. The prisoners ended their Hunger Strike after assurances they would be sent to Ireland. A month later, Frank was transferred to Long Lartin Prison in Worcestershire.

Frank again refused to do prison work and was held in solidarity confinement. Himself and his family were subjected to humiliating strip searches. In protest, he began another Hunger Strike on October 10, 1974. He ended his fast after 34 days after the prison Governor agreed to end the strip searches and promised again, he would be sent to Ireland.

In March 1975, The Price sisters, Gerry Kelly and Hugh Feeney were sent to prisons in the North of Ireland. Frank was denied. He was transferred to Wakefield prison in West Yorkshire, where he was again held in solidarity confinement for refusing to do prison work.

His mother in particular made difficult journeys to visit him in different prisons to which they kept transferring him.

On December 14, 1975, Frank began another Hunger Strike with several other prisoners. Tired of the empty promises, he wanted assurances in writing this time. His demands were:

- *No solitary confinement
- *No prison work
- *Repatriation to prison in Ireland.

The authorities refused to meet his demands. Frank Stagg died on 12 February 1976, after 62 days on Hunger Strike. Shortly before his death, he wrote his final message: "We are the risen people, this time we must not be driven into the gutter even if this should mean dying for justice. The fight must go on. I want my memorial to be peace with justice."

Frank indicated his wishes to have a Republican funeral and be buried in the Republican plot at Leigue Cemetery in Ballina with his comrade Michael Gaughan. His body was to be flown to Dublin airport, but the Irish government ordered his body to Shannon airport. It was airlifted to Hollymount. They were anxious to avoid a showing of support as there had been for Gaughan's funeral.

On Saturday, February 21, a private mass was held, and the body was taken to Ballina, to be buried in the Leigue Cemetery, but not in the Republican plot. Six feet of cement was then poured over the body to prevent it being moved. The next day, members of the IRA held a military funeral for him, with a customary volley of shots. Joe Cahill, former IRA Chief of Staff vowed that Frank's body would lie next to Gaughan's.

On November 5, 1977, his brother George Stagg and a few volunteers dug into the adjacent grave and tunneled under the concrete to retrieve Frank's remains. Proinsias Stagg is now buried as he had wished, next to his comrade Michael Gaughan; in the plot reserved for the Republican heroes of County Mayo.
